Sub:- Extension of Time for submission of online application for Renewal/Validity of proposal in respect of institutions yet to submit the proposals.

The procedure to be followed for online submission of proposals for Renewal/Validity was earlier notified and the last date for submission of proposals was 31.01.2017. However it is noticed that some institutions have not submitted their application online as yet. Since the online submission of proposals was introduced this year for the first time, as an exception for this year, it has been decided to allow **time from 01.04.17 to 21.04.17** to such institutions to submit the proposals for Renewal/ validity online. **It is to be noted that proposals from all the pending institution should necessarily be received on line within this time period. Proposals received in any other format will not be considered by INC.**

Those institution which have submitted their proposal on line for renewal/validity already, can verify the status of their proposal using their User ID and Password. Shortcomings, if any pointed out, should be **complied by 15th July, 2017.**

Those institutions which are referred in para 1 above may also login after 21.04.17, to verify the status of their proposals submitted on line. **The last date for compliance of deficiencies in their case also will be 15th July, 2017.**

No Proposals of compliance will be entertained after **15th July, 2017 under any circumstances.**
